1. F.I.T./Individual Bookings Policy for Royal Caribbean International Qualified Bookings sailing in 2019 and beyond.

Option Length (days)	Option lengths vary based on the sailing status
Option length grace period	None
Full Deposit (per person)	Up to 5 nights=\$100 6 – 9 nights=\$250 10+ nights=\$450
Full Deposit due	Required with the first billing cycle after the original option date; unless within final payment period.
Names Due	At time of booking
Name Changes	Name changes can be made to all but one of the original names listed on the booking. Name changes are not permitted on code red sailings. Name changes are not permitted at any time for code red sailings or any sailing that has been code red.
Final Payment Due Date (days prior to sailing)	30 Days for non-Holiday Sailings 90 Days for Holiday Sailings

Cruise Tour/ Cancellation Charges	Cancellation charges are assessed based on days prior to the start of the cruise tour package. Terms & Conditions vary by brand by product.
Hotel Cancellations	<ul style="list-style-type: none"> • 30-8 days prior to departure = 50% of the package cost • No refunds will be made to "no shows", cancellations within 7 days of departure, hotel packages interrupted before their termination or guests with improper documentation. <p>NOTE: The cancellation penalty for the hotel will reflect in the booking 24 hours after the tour code is cancelled. Please ensure the Travel Agencies are made aware that the penalty will be applied to the booking.</p>
3 rd /4 th berth Cancellations Charges	<p><u>Outside of 100% penalty period:</u> If a stateroom is trip/quad occupancy and the entire reservation cancels, all guests will be assessed a cancellation charge as listed in the above – Cancellation Charges section of this table.</p> <p>Taxes & fees are refundable.</p>

	<u>Within 100% cancellation period:</u> Full penalty is assessed for each cancelled passenger once they are inside 100% penalty, at the rate they were booked under. Taxes & fees are refundable.
Tour Conductor Credits	None
Changes to Bookings within Cancellation Charge Period	Not permitted. (Any sail date changes made to bookings within cancellation period via an exception will carry forward the penalties from the prior sail date).
